How can we identify school advocates to support children who may still be in school? Having a liaison between schools. 	Stan indicated that state mandate (AB2412/1767) requires all public schools serving pupils K-12 have comprehensive suicide prevention policies. Protocols for effective postvention training is included in CDE sample policy.  Stan recommended Brandy (LOSS Team, Fresno) speak with our Team and to the Collaborative in January+. We want to be sure we have the right people at this Collaborative meeting who will play a role.
